Names Project Director at December HTG Meeting

Cleve Jones, Executive Director of The Names Project, received a standing ovation after addressing over 150 High Tech Gays members at the December meeting. A total of \$411 was collected at the meeting which will go to 18 different AIDS services throughout the Bay Area. HTG made a \$100 group donation and the additional \$311 was donated following the presentation.

In his address, Jones expressed how the idea evolved for the project. It began on November 27, 1985 during a candlelight march for Harvey Milk and George Moscone. About 1000 people had died of AIDS in San Francisco at that time and he thought that a good way to remember those people would be to carry a sign with a name of someone who had died. The march converged at the Federal Building where, in a need to express their feelings, all of the marchers covered the walls with their signs. Later on, Cleve says he got the idea of a quilt.

Several dramatic things happened soon after the march that angered him and gave him the momentum to push ahead with the project: including: his best friend died; and, after CBS aired *Life and Death in San Francisco*, he received death threats, and he was involved in a gay bashing incident in Sacramento..

To Jones The Names Project shows how gay people love each other and offers them a way to share that love with the rest of the world. In June of 1987 there were 40 panels to the quilt. By October of 1987, there were more than 2300 panels on display at the National March on Washington. To show the enormity of the epidemic, the



quilt now has over 10,000 panels. The recent showing in December 1988 at the Moscone Center in San Francisco was the largest single showing to date with more than 7,000 panels on display.

HTG vs DISCO Update

On Friday, December 16, the Ninth Circuit Court of Appeals finally heard oral arguments in the US Government's appeals of "High Tech Gays vs DISCO (Defense Investigative Security Clearance Office)". This case, which seeks equal treatment for gays and lesbians in the obtaining of Security Clearances to work on government contracts, had previously been ruled on in favor of HTG by SF District Court Judge Thelton Henderson.

A three judge panel, made up of two Circuit Court judges and one District Court judge, heard arguments from the government's lawyer (who came all the way from Washington), and from our attorney Dick Gayer who initiated the suit four years ago. The arguments were limited to one hour and consisted mostly of the lawyers responding to questions from the judges who had previously studied the arguments submitted in writing.

According to Dick Gayer, there are four possible outcomes: One, they can uphold Judge Henderson's ruling, and we win. Two, they can reverse Henderson, and we lose. Three, they can determine that Henderson's "summary judgement" ruling was too hasty, and remand the case back to Henderson for further hearings and a full trial. And four, they can choose to simply wait until other gay cases being reviewed by the Ninth Circuit (like Perry Watkins vs the CIA) are settled and see what new precedents may be set which could affect HTG vs DISCO.

Gayer added one more wrinkle by bringing in excerpts from a brand new Rand Corporation study which criticizes the government for making any important personnel decisions based to pre-hiring interviews. The HTG Newsletter San Jose, California

HTG BBS Gets Software Upgrade

The HTG computer bulletin board system was recently upgraded from TBBS 2.0 to 2.1. Some of the new features that TBBS ("The Bread Board System") 2.1 offers are:

XModem, YModem, YModem Batch, SEAlink, Kermit, and SuperKermit file transfer protocols.

Faster message access and an improved method for reading multiple messages boards with a single read command.

"Carbon copying" of messages and "message read receipts", along with the capability to upload message text using a file transfer protocol.

a greatly improved and reorganized file download area with multiple file download areas and automatic scanning of all download areas for any files added since your last logon.

support for ANSI Color Graphics and IBM Graphics characters.

Many other improvements too numerous to list here. Since its inception in June, the HTG BBS has fielded over 4000 calls and 2500 messages. Currently, the system has about 600 different callers and 1360 active messages. Information about HTG, including monthly activity calendars, club membership information, and security clearance information, is available online. Multiple message areas, file downloading/uploading areas, and national lesbian/gay resource listings are available to all callers.

The system, located in San Mateo, runs 24 hours a day, 7 days a week, and supports 2400, 1200, and 300 bps access. The number is (415)572-9594. No validation, subscription, or registration is required; pseudonyms are welcome, and you don't even have to be an HTG member to call. (In fact, we've recruited several new members who have who found out about HTG through the BBS.)

If you use Telenet's PC PURSUIT service, keep in mind that the HTG BBS is PC-Pursuitable through either the San Francisco (CASFA) or Palo Alto (CAPAL) Telenet PC PURSUIT nodes.


