Our topic for the evening was financial and estate planning for the gay and lesbian household, organized by HTG member John MacKintosh, a CPA from the firm Petersen/Ginner, Inc. Participating were Stacy Saetta and James Cashman, attorneys from the law firm Berliner • Cohen; and Gaylord Galiher, a Financial Consultant with Merrill Lynch.

The group worked put together an interesting presentation. During a dry run of the program, they determined that to cover all of the topics and answer the questions, the presentation would take over two and a half hours. To fit into the HTG meeting time constraints, they were forced to abbreviate quite a bit, and were only able to touch on some of the key points. John led off the program, introducing the panel and the topics to be covered.

Historical Background

Stacy Saetta discussed some of the background on lesbian and gay families. She listed several companies that, to some extent, already recognize nontraditional households, such as AAA and Costco, which give "spouse" cards to domestic partners. She also spoke a bit about the ramifications that will occur if/when same-sex marriages are legalized.


Developing a Financial Plan

Next up was Gaylord Galiher who spoke about financial planning. He distributed an outline of the presentation titled "Financial and Estate Planning for Individuals, Domestic Partners and Their Families."

Gaylord began by stating how anyone can benefit from a sound financial plan, not just persons in higher income brackets. Billy DeFrank Center Update

Last month I attended the Billy DeFrank Center's Annual Membership meeting. They were electing new members to the board. As those of you who attended the "Isn't It Romantic" Dinner/Dance know, Michael Mitchell was elected as the new president, and HTG member Mark Patrosso is now on the board. You can get a complete list of new officers and board members from the DeFrank newsletter.

What? You don't get their newsletter? My goodness, that means you're not a member of the fourth largest Gay/Lesbian/Bisexual Community Center in the whole US of A!. This wonderful community center is overflowing with activity:

- · It serves as home to many organizations such as HTG who hold their regular meetings and special events at the center.
- Events from animal obedience classes

to stop smoking programs are held regularly.

- It houses the switchboard, which is often a person's first contact with the community.
- It is a source of information for both the lavender and straight community.
- It is a place to redefine family, when our blood throws us out the door.
- It offers emotional support with mental health counseling.
- Services specifically for the youth of the community are now being offered.

As many of you may know, the Billy DeFrank Center is planning to move within the next year. The main reason is that the current building is too small! Another is the new San Jose Arena just around the corner. The Center is supposed to be a safe place for people to come, and the perception of "beer-swilling hockey fans" causing problems is very real. Whether this actually becomes a problem will remain to be seen as the hockey season

begins. Also as a point of first contact for someone frightened about coming out, or even being seen in the community, that corner of Stockton just has too much traffic.

To take on the task of finding a new home, a relocation committee has been formed. Their primary focus is to seek out a site and people with the expertise in locating and securing capital funding. The goal is that the next Billy DeFrank Center will be owned, not rented. Staying in San Jose is a priority, along with safety and adequate parking. The target is to be in a new facility by June of 1994.

How can you help? Become a member of the Billy DeFrank Center. Better yet, become an Acorn member, where you send the center a few dollars (\$10, \$25, \$50) per month. This helps provide a stable foundation of reliable monthly income. Then come use the center, and support its many events.

domestic partner when it comes to financial and estate issues.

He finished by mentioning the eight points Merrill Lynch emphasizes when analyzing a financial plan:

Net worth

- Tax considerations
- 3) Current &retirement asset allocations
- College education planning
- 5) Estate planning analysis
- 6) Retirement analysis
- Disability analysis
- 8) Survivorship analysis

Estate Planning

The third speaker was James Cashman who spoke about Estate Planning. sound estate plan will make sure that your wishes are carried out after you die.

James discussed a few of the ins and outs of probate. Probate is probably one of the most disliked words when it comes to settling a person's estate. In California, getting through probate usually takes a minimum of one year. Also, all records in probate become public documents that anyone can see.

He stated that there are two ways that you can avoid probate with your major assets:

- Hold property as a joint tenancy.
 This will transfer the entire property to the surviving partner.
- 2) Create a revocable living trust. This transfers all of your assets to a trust of which you are in control. Upon your death the trust is transferred to whomever you specify. Because the legal title to the assets is held by the

trust and not by you, the trust will not be subject to probate.

Another element in an estate plan is the need to update and keep current Life Insurance and retirement plan beneficia-

His final point was with regard to two critical health care documents.

- 1) The Durable Power of Attorney for Health Care -- this allows you to appoint someone to act on your behalf with health care decisions. This power is effective only upon the physical or mental incapacity of principal person.
- 2) The Declaration Concerning Life Systems Treatment ("Living Will") -this expresses the person's desire not to be kept alive on life support systems when there is no prospect for recovery.

James also provided literature on some of the most commonly asked questions with regard to estate planning.

These presentations were only a brief outline of what should go into a sound financial plan. Everyone is different with unique circumstances that often cannot be adequately covered in a printed financial planning guide. Therefore, it is highly recommended that a person spend at least an hour with a financial planner to go over their specific needs.

We would like to offer a big thank you to Stacy, Jim, and Gaylord for their presentation, and a very special thank you to John for pulling this all together. It was a very enlightening presentation.



LAVA Awards

The Lesbians of Achievement, Vision, and Action (LAVA) Nominations Committee invites you to submit nominees for the following awards to be presented April 2, 1994. The awards honor persons whose contributions have enhanced the image or understanding of lesbians within or outside of the community.

Three awards are offered in the following categories:

Public Service - for an individual who has demonstrated the above contribution in the areas of government, politics, education or any other government supported function.

Private Creation - for an individual who has demonstrated the above contribution in areas such as the arts or business where the livelihood is supported by the creation of a product or service.

Community Service - for an individual who has demonstrated the above contribution in areas supported by community funds such as nonprofit agencies or political organizing groups.

General Criteria

- The nominee must have specific, identifiable accomplishments which demonstrate leadership in the fields defined by each award

Jean Kovalich Settles with D.I.S. -- HTG to Get Refund

After nearly two years of battling with the Defense Investigative Service on a charge of anti-gay discrimination, Jean Kovalich reached an out of court settlement on December 12 (1987).

Kovalich stated that she is "happy to remain a member of the agency family and welcomes the end of the litigation."

Attorney Dick Gayer said that he felt that the government was using the Kovalich case as a test of the strength of the gay community, to see how far it could be pushed. They now know that the gay community cannot be robbed of its rights and remain passive, he asserted.

In 1985 Kovalich had been promoted to Supervisor of investigators, when during a normal clearance review interview, DIS "discovered" that she was a lesbian, a fact she thought was widely known and accepted. She was promptly removed from her supervisory position. DIS contended that being a

lesbian her Looking Back... made unsuitable for supervisory position and, HTG additionally, that she did not "admit" 1993 1983 to being a lesbian she before

Kovalich and attorney Gayer sued DIS for discriminatory practices and, just before the case was to go to trial, Federal District Court Judge Legge suggested that the government accept an out of court settlement.

was asked.

Seeing the handwriting on the wall, and afraid of the precedent which could be set by losing the case through a trial, the government caved in and settled.

According to Gayer the terms of the

settlement include:

 Kovalich will be reinstated to the first supervisory opening which may come along;

 In the meanwhile she will receive the grade (GM-13) and pay of the supervisor's position while performing the duties of an Investigator (level GS-12);

She will receive back pay at the supervisor's rate;

4) The record of her demotion from supervisor will be removed from her personnel file; and

5) The government will pay all court and attorney fees she incurred.

High Tech Gays contributed \$500 to Jean Kovalich from out HTG Legal Defense Fund and Dick Gayer expects that when he is repaid by the government for the court costs, HTG will receive back its \$500. This money will go back into the HTG Legal Defense Fund to assist some other gay rights litigant.

Sanctuary For Children

Recently, I have become involved as a volunteer with an organization that should be interesting to others in the gay community. The Sanctuary for Children seeks to help "throw away" kids living on the streets of San Jose. It turns out that about a third of these kids are gay or lesbian. What a tragedy that the families of these kids have made life so miserable that living on the street is preferable to staying in the family unit.

The Sanctuary staff, many of whom are "graduates" of the street, work with these teenagers, 12 to 20 years old, in an open, accepting, trusting environment to show them that there are better ways of living their lives. Left on the street, they are prey to drug dealers, child pornography producers, and/or prostitution rings. The Sanctuary, working with very limited resources, provides outlets for the energy of the kids through art and theater projects which are run, to a large extent, by the kids themselves. Food, shelter, clothing, and necessities are provided where possible. Accepting them as they are and not trying to force them into an "acceptable" societal mode promotes the kind of trust that makes development

of more positive self image possible. Success to the Sanctuary staffer is to see a kid grow toward self-sufficiency and self-confidence. Failure is sometimes characterized by death.

Why am I writing this? I am hoping there are others like me who care about what happens to other gay people in our society and who might want to reach out to help. More than anything, donations are needed. If you are looking for a meaningful place for your charitable dollars, think about the Sanctuary for Children. If your company matches gifts, as mine does, that is even better. The Sanctuary does not accept or solicit money from political entities - they want to control, and that defeats the building of trust these kids need. Corporate and personal gifts are the main source of funding.
